ANALYSIS: 170 CAMPAIGN CONTRIBUTORS DONATED \$50,000 OR MORE IN 2013 **BIG DONORS PUMP \$28 MILLION INTO CAMPAIGN COFFERS** MEGA-DONORS ACCOUNT FOR MORE THAN HALF OF DONATIONS TO NEW YORK STATE POLS **GOVERNOR CUOMO LARGEST BENEFICIARY OF LARGESSE**

170 campaign contributors donated \$50,000 or more to state-level candidates and party committees in 2013. They contributed a total of \$28,211,646.61, representing more than half - 51.41% - of all the money donated by New York's 19.7 million residents.

Most of the mega-donors took advantage of various loopholes in the state's campaign finance system. For example, James Simons, number one on this list, was legally allowed to give \$1 million to the NYS Democratic Committee's Housekeeping account. Number two, Leonard Litwin, made donations from 21 different limited liability companies ("LLCs").

Ten Biggest Recipients of donations from the State's Largest Donors

Governor Cuomo was overwhelmingly the largest beneficiary of the current system. Donations to his campaign committee and to the housekeeping account of the NYS Democrats - which spent millions of dollars running television advertisements featuring the Governor selling New Yorkers on his agenda – accounted for 40% of the total money raised from this list of mega-donors.

¹ These numbers only reflect donations made to statewide candidates, legislative candidates, statewide political parties, or leadership PACs maintained by state legislators. Several donors on this list donated substantial amounts of money to Super PACs involved in 2013 elections in New York City; these totals are not included. The numbers in this report were based on what was reported by these committees. Donations to committees who filed their January 15th disclosure reports more than two weeks late are excluded. It is possible that some of these numbers could actually be larger, since we have not been able to identify every single vaguely-titled LLC that has donated to candidates in New York.
